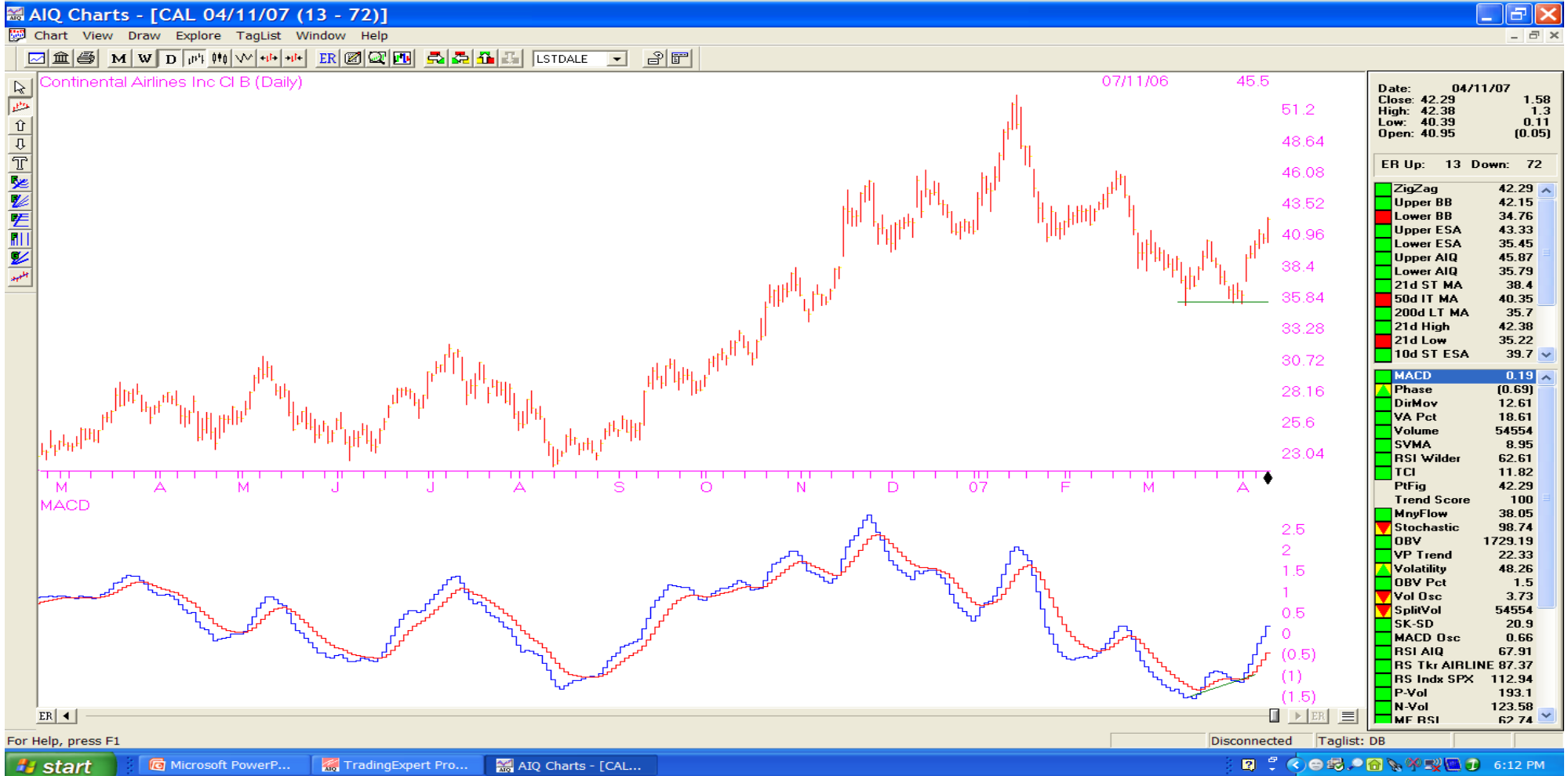
APC Daily Divergence(Nat Gas)



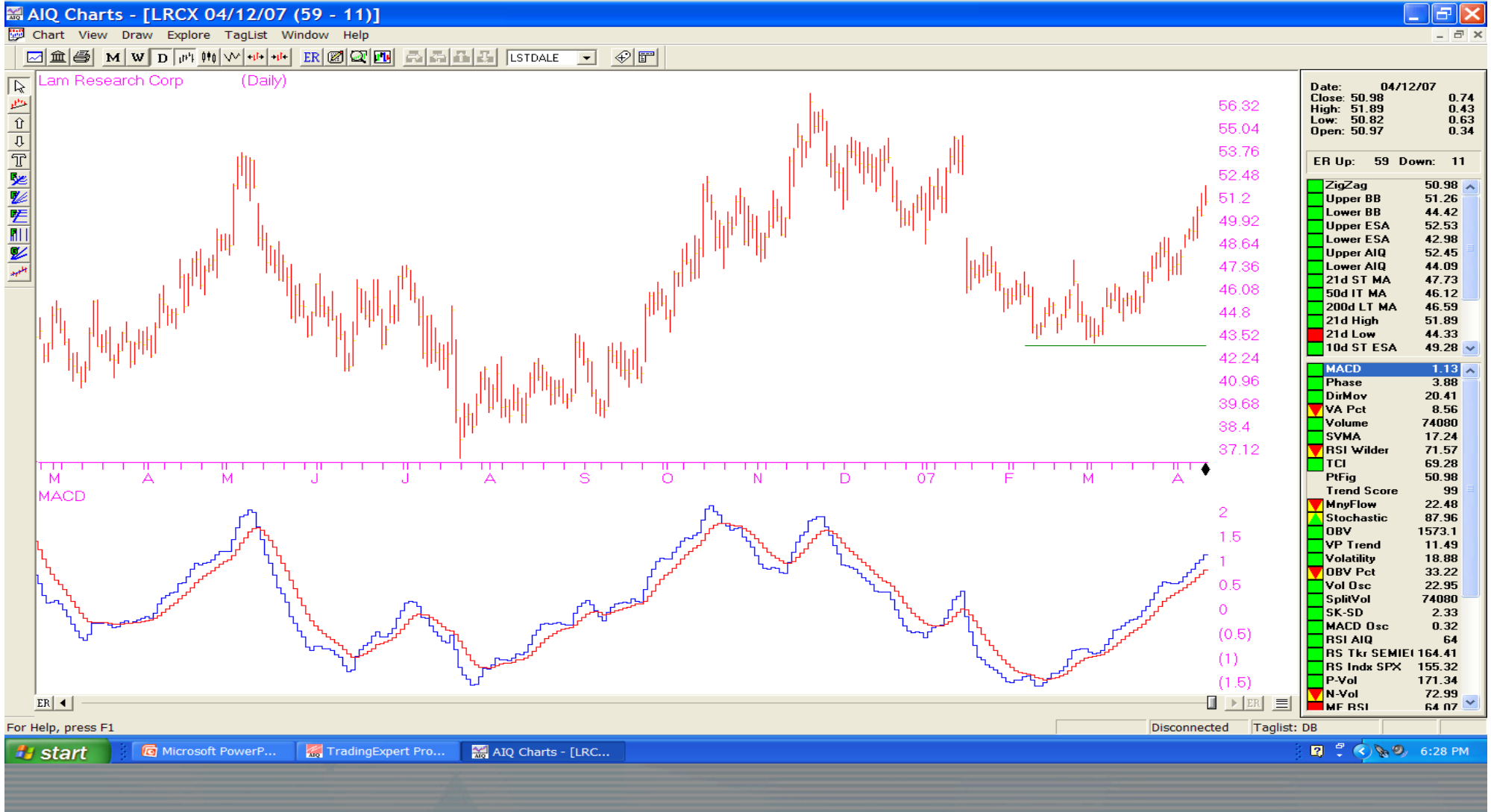
GAS Daily Divergence-(Nat Gas)



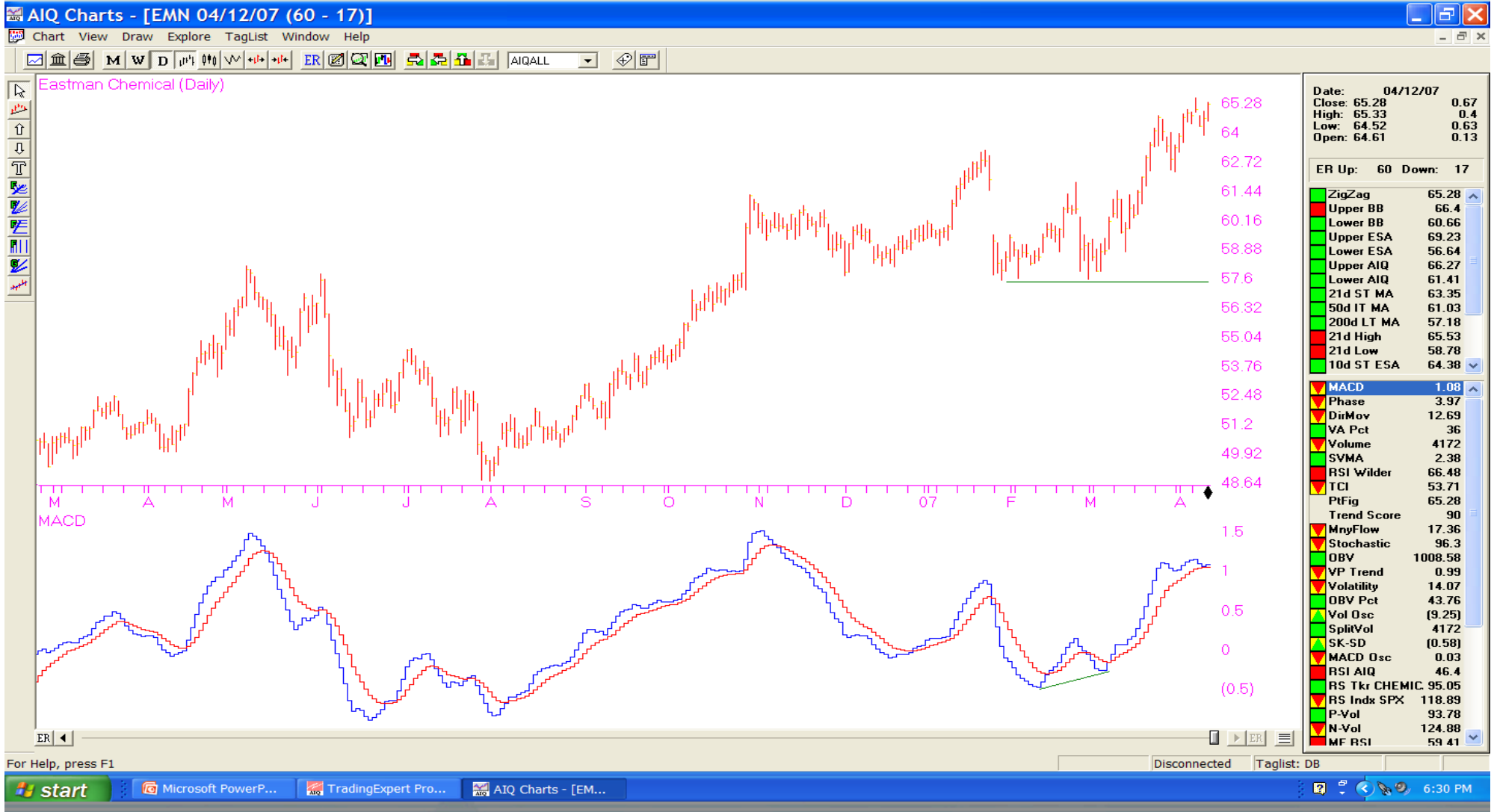
CAL Daily Divergence
